Dear Daniel and HGMD Board members,

My name is Gina Abegg. I spoke to you previously about my desire to implement a solution to a long standing challenge to grandparents in our age restrictive community. At this time, the only things open to share with children are the pool two hours a week and the restaurant or use picnic pavilion..

I envision a "Grande Pere" (Grandfather) or Grand Pair mini-park in a small natural area at the edge of our community. I would like to put in permanent fixtures that could be enjoyed, including a checkers and chess table, a two person swing, a bench to watch the birds and other wildlife across the fence in the Cherry Creek Park spillway. In the parking area next to the park, I would attach three heights of basketball hoops. There would also be a storage shed to keep smaller games like cornhole, ladder toss, and basketballs and binoculars. If the Heather Gardens Metropolitan District approves, I would also like to have some wind chimes, which are not allowed normally in Heather Gardens. This area is far enough from residential buildings that no one would be disturbed.

I am in an early stage of developing a plan for this and am still trying to find a timeline for completion of a grant proposal. Specifics would, of course, need to fit the space and be approved by you.

Please consider approving of the concept so that I may continue to work on this application to the city. These minigrants are for \$5,000.

If ok in concept, I will return to you with specific expenses and a final design.

Daniel, I copied you on the letter I sent to the city's mini-grant officials. I will keep you in touch with progress from that end. I would also like to be scheduled to speak at one of your meetings to share this idea.
