 - a. Designated Election Official to deliver recall petitions to board. Pursuant to C.R.S. §32-1-910(4)(a)(II), within 30 days following the issuance of a final order finding the petitions are sufficient, the board will hold a regular or special meeting to set a date for the recall election not less than 75 days nor more than 90 days from the meeting date.
 - In the *Benzen v. City of Boulder* case cited by the DEO for other reasons, the district court entered a temporary restraining order enjoining the city from taking any steps toward setting a recall election date until the appeal had been resolved. HGMD intends to follow the statute, so no restraining order is needed in this case.
 - b. The Comcast Fiberoptic Project has been referred to litigation counsel who will notify Comcast that all further communication concerning fiberoptic cable be done through his office. I have forwarded the email dated December 6th, the same day as their purported agreement to install fiberoptic to the clubhouse to the litigation counsel, which refers to the District board meeting the following day Dec. 7th for the vote to remove the RV lot from the previous contract and states, "There was a form from the agreement for the clubhouse I just submitted. This is not a service contract. This allows us to survey, repair, and service the clubhouse. It is a MSA and does not bound the community to any to any additional services."
 - c. Regarding the litigation with HGA, HGA finally on Monday agreed to a trial date of September 30th. As I stated before, HGMD accepted the proposed date the court gave in June, but HGA refused and argued for a date in December. Given the assertions by HGA counsel that HGA will not negotiate or consider settlement offers

until the conclusion of a recall election, if any, we pushed for the earlier date. But both parties must agree on the trial date, so September 30th was the best we could do.
